Schools In and Road Safety

I want to emphasize the importance of summer safety now that school is back in session. These days bring congestion. School buses are picking up passengers, kids on bikes and in cars are hurrying to get to school before the bell rings, parents are trying to drop kids off before work. It's never more important for drivers to slow down and pay attention than when children are present, especially before and after school. According to research by the National Safety Council, most of the children who lose their lives in bus-related incidents are 4 to 7 years old, and they're walking. They are hit by the bus, or by a motorist illegally passing a stopped bus. A few precautions go a long way toward keeping children safe:

Tips for Safe Driving

- 1. Obey all traffic signals and stop signs. Running stop signs results in civil penalties and demerits on your license.
- 2. Share the road safely with others.
- 3. Avoid texting while driving.
- 4. Familiarize yourself with bike: laws.
- 5. Be aware that fast-paced, loud music, podcasts, or audiobooks can increase arousal and negatively affect driving performance. These can also require high cognitive processing and lead to fatigue and distraction.
- 6. Don't block the crosswalk when stopped at a red light or waiting to make a tum, forcing pedestrians to go around you; this could put them in the path of moving vehicles.
- 7. In a school zone when flashers are blinking, stop and yield to pedestrians crossing the crosswalk or intersection
- 8. Always stop for a school patrol officer or crossing guard holding up a stop sign
- 9. Take extra care to look for children in school zones, near playgrounds and parks, and in all residential areas
- 10. Don't honk or rev your engine to scare a pedestrian, even if you have the right of way
- 11. Never pass a vehicle: stopped for pedestrians
- 12. Always use extreme caution to avoid striking pedestrians wherever they may be, no matter who has the right of way

Manager's Report

Mr. Snowden stated that the fireman's parade taking place on Saturday, September 6th, at 12 noon. Remember Mayor, you and I will be judging some of the events. I hope that all of the Board and Village officials can make it. There will be vendors, plenty of food, children's event, live music and also fireworks to finish out the night.

West Broadway will be closed tomorrow, we have a major dig that will take place up there, traffic will be rerouted and we have already been in contact with the school district and have rerouted the school buses.

There were two major water breaks. There was one in front of Beer World that was sealed, but we are waiting for a 14" valve that is currently unavailable. We were told that we can either get six months from now or six weeks from now, but we are trying other places to get the valve, once received, the break can be repaired and the road can properly be sealed. There was also one on Patricia Place, we repaired the pipe and went to turn the water back on, and the pipe split another 8ft, so now we had to replace another whole eight feet of pipe.

Regarding the speed humps, we have already identified additional streets that the speed humps will be installed on, Lake, Park, Spring & Waverly, if there are any other streets that need them, please

let me know and we will look into it. Board members, the Highway Superintendent, did go out and mark the streets that I named, if you agree with those placements, please let us know and we'll move forward with the installation.

Legal Update

Thank you Madame Mayor, I do want to address the board and the community in light of the various statements that have been made by the District Attorney that need a response. I'm doing this because it seems to me that there is a great deal of misinformation that is being circulated intentionally and perhaps maliciously and that is not going to go unchecked by this Board or by me. So please bear with me for a few minutes that I feel need correction. I am going to start by giving you some autobiographical information which I believe the community needs to know and then I'm going to address the most recent press release by the District Attorney and the various statements and misstatements in that. Let me start this way:

Brian Conaty, Esq., the District Attorney of Sullivan County and our County, was admitted to the New York State Bar in 2018, forty years after I graduated with Honors from Harvard Law School. His professional accomplishments to say it plainly, are minimal.

After I graduated law school, I worked for the United States Department of Justice in Washington, D.C. as a trial lawyer in the Civil Rights Division and then starting in May of 1891, as Assistant General Counsel for the National Office of the NAACP. After I won the Yonkers desegregation case in November 1985 [following a 92-day trial in federal court], I opened a law office with my father in Yonkers who never practiced law and we were about to spend the next sixteen years trying to remedy forty years of racial segregation and discrimination against people of color in that city. Between January 1986 and July 2002, I represented thousands of people in major civil rights cases around the United States.

In 2001, I ran for Orange County Executive. I defeated the Democratic Party's nominee in a fair and free primary, 55-45. After the great tragedy of 911, I lost the General Election. A few months later, the governing grievance committee investigated me for commingling funds. The underlying issue was this: when I received a settlement check in a case, I immediately paid my client's share to him or her and did not maintain the settlement funds in an escrow account until the settlement proceeds "cleared" the bank. I should have done so and acknowledged this technical violation. However, no one ever accused me of stealing or taking a penny, a penny of anyone's money and the retired Judge who adjudicated the case from the appellate division reported that I was not only never accused of that, but never did it.

The Appellate Division suspended me for a period of one year and served the suspension and then resumed my civil rights practice, which at that time was primarily in federal court. Since 2003, for the last 22 years, I have represented people of every religious faith and race and almost every disability and major civil rights litigation across the United state. It was in that way I met Gordon and James.

In April 2022, with a new Board having been elected in the Village of Monticello and having known several of you personally, I agreed to serve as the Village of Monticello special counsel because I wanted to help

turn the village around, to provide sound counsel to its leaders and enforce its laws. I prosecuted building and zoning cases and our vehicle and traffic docket for more than a year, no one said anything about it, no one said anything about it. In August 2023, a new board majority, with the switch of Mrs. Rue from your majority, to perk a new majority, fired me and Mr. Snowden, who was then, the Village Manager. When that majority was voted out of office in March 2024, Mayor Massey and the new Board unanimously re-hired me to resume my service as Village Special Counsel and I remain in that position.

To question my integrity, is beyond the breech. Questioning the integrity of any of you without any facts is beyond the breech, it's disgraceful. It's disgraceful for any elected official to make a statement like that about any of you, let alone me, I have been before the bare for over 47 years. I have focused on our enforcement efforts on landlords who rent units without rental permits and homeowners who create messes on their property with no regard for their neighbors. I tried to strictly enforced speeding laws designed to keep the village safe as you just mentioned Madame Mayor and seatbelt laws designed to protect children. As far as I know, I have served honorably and evenhandedly enforcing our law.

Now, the voters of this County elected Mr. Conaty District Attorney after less than five years of legal practice. Having been elected, he has the right to wield the authority of that office, including representing the People in the cases we have handled here. But one would not expect an allegedly short-staffed office to focus on these matters. There are more serious crimes in this County. The District Attorney had and has and I repeat, had and has, no good reason to "reclaim" authority over prosecutions of building code violations or Vehicle and Traffic cases arising from the Village of Monticello. His personal attacks on you and on me are deflections from his baseless assumption of authority.

Now I want to address some of the specifics of that we've been reading about, rather some fanciful specifics, first:

The Village Board had every right to hire a fully qualified person as a constable when you set up the constabulary function. The same gentlemen served for 3 years and is continuing to serve as a Constable in Woodridge in the act without a peep from the District Attorney. If its permissible for the gentleman to serve there, it must be permissible to serve here. Moreover, there is no legal impediment for his service. DCJS does not present an obstacle as the District Attorney has suggested, there is no obstacle. Moreover, the same District Attorney claims that he can't prosecute cases that this gentleman produces has prosecuted those very same cases through his office in Woodridge. Mr. Conaty may disagree with the decision to hire this gentleman, which is his right, everyone has a right to disagree, but it's a weak basis to disallow the Village to enforce its own laws.

Mr. Conaty also suggests that we have no basis for claiming concern about his enforcement efforts, when the opposite is true. We have a serial violator of our zoning and building code in this particular Village. That gentleman consented, consented to a \$33,000.00 fine because of his myriad violations and even after that he continues to act like it's optional to follows the laws of this Village and we were prosecuting him again successfully, because he had no defense and yet suddenly, the

case is dismissed, with no sanction in the first appearance of Mr. Conaty. That's a disgrace to the Village; it's an insult to the Village.

These are statements that appear in a Public document issued by a district attorney in this state, quote, "Over the last several months numerous allegations were brought to my office, the question integrity of the Village individuals charged with running the Village of Monticello." You don't make statements like that without facts to support them. I'd like to know what individual came forward and what question was raised about the integrity of myself, Mr. Snowden, any of the five of you and any of the other existing officials in this Village. And if there are some statements they should have been brought to our attention, so we could deal with them and not make broad statements in an irresponsible nature like this.

In regard to the individual that I reference earlier as a Constable, this gentleman writes, quote, "that individual is currently being prosecuted by my office." Here's the truth, that individual was prosecuted by his office, that individual has an attorney, not me, who made a motion to dismiss the prosecution, that motion was adjudicated by Judge, Justice Schick, right here. Justice Schick issued a decision highly critical of the prosecution and dismissed it more than a year ago. There's no current appeal pending, a notice of appeal was filed, but never perfected. You file a notice of appeal within 30 days of a decision and you only have six months to perfect your appeal. That was not done by the gentleman. Then for him to write publicly and quote" the individual is currently being prosecuted" is a lie. The individual is *not* currently being prosecuted.

Next, questions have also been raised to my office as to the Village's integrity while processing the Village ordinances. Really? By whom? What questions? Were they raised by the person who pled guilty to probably 50 violations?

Let me put it to you very simple, with regard to the building and code enforcement efforts in this Village, not one individual has come to court and defeated any of the notices of violation which Mr. Snowden has approved or wrote or that we prosecuted, not one so, what's he talking about? Public life cannot descend into fact lessness. Without a moral pedestal and without any regard for the truth, public life descends into the kind of lawlessness we have in Washington DC. We don't need that in Sullivan County, we don't need it for one minute.

S, ladies and gentlemen, in conclusion, thank you for these 12 minutes to try to clear the record. I believe the community has every right to ask whatever questions you have about this rather scur lisness nonsense. I think you should be outraged that a District Attorney would come and allocate functions that we have been performing with honor and properly. The District Attorney should have bigger fish to fry than vehicle and traffic violations in Monticello, which are being handle properly by our Court. And I want to say in regard to these 5 people that are sitting in front of you as your Board of Trustees, I have served in 2 stents here, now for approximately 26 going on 30 months, none of them have ever that anything be done that is unethical, inappropriate not even discussed in any way shape or form. This Mayor has never suggested anything improper, and no member has ever suggested anything that would even come close to suggesting a lack of integrity. Their interest has been on bettering this community, period and for a District Attorney to make comments like this and

circulate them in the Public, when half of the people believe what they read and most people don't know what he's talking about and he never makes clear what he's talking about with these broad allegations is frankly disgraceful. If he wants to come here or debate me about any of these issues, I'm glad to meet him at the place of his choice.

It is well known that I'm running for County executive in Orange County. I am the democratic party nominee. I won that nomination unanimously with no primary in 2025. Mr. Conaty is s democrat, so I don't say this is about partisan politics, but sometimes interparty rivalry no matter how baseless they may seem are worse than those between political parties. I have no ideas what is motivating this and I don't care. What I care about is the baselessness of the allegations particularly as against Mr. Snowden, perhaps our Village Clerk, I don't know who he's referring to. Thank you for these few minutes, I appreciate the chance to address the issues.

Trustee Jenkins responded and thanked Mrs. Sussman for his words. He went on to say that, and you know sitting up here on this Board and in this Village and hearing the things that you just said, in my 65 years, this stuff sickens me, it makes you bitter about what's happening here and it's not nice. You know we try our best to sit here and do the best we can for this community and it seems like every time we try to group and do a decent job here, we just get attached and for what? All were trying to do is help this community, there's nothing in it for any of us in this community and just want to make it better for all of us. We want to leave a legacy for when were dead and gone, that we strived to have a better Village and that's all we're here for. Michael I appreciate that, but it saddens me.

Mr. Sussman responded well, good people should stay involved. I know it saddens you and makes you upset, it makes everyone upset to feel unjustly attacked. But the reality is, if you vacate the arena, you leave it to people who are making false statements and it makes it seem like what they are saying is true. So, it's important to speak up and fight back and not quiver in the face of nonsense.
